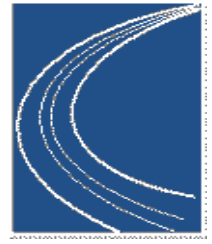

Utilizing a PAC is an essential element of TRALA's government relations objectives. It is crucial that TRALAPAC has sufficient funds available at its disposal to keep our industry's vital interests well represented in the public policy process in Washington. TRALAPAC is an essential tool for TRALA's government relations team by allowing it to support candidates who are receptive to TRALA's views on issues directly affecting our industry.

*Our objective is to have TRALAPAC serve as **the** political voice for the truck renting and leasing industry and it will help our continuing effort to build a top flight government relations program.*

TRALAPAC — Our Mission

The mission of your association's PAC is simply to gain TRALA members and our industry fair and adequate consideration in federal public policy decisions. Our strategy to achieve this is to continue to combine sound and vigorous public policy representation and advocacy with increasingly active and judicious use of political fundraising.

TRALAPAC — Identifying and Aiding Key Candidates

TRALA's professional staff and its Government Relations Committee tracks key issues in the federal public policymaking process, and the elected legislators and candidates who support and give their consideration to the many issues that are of vital interest to TRALA member companies and our industry. Our association's new TRALAPAC Committee, as a part of its oversight responsibility for the TRALAPAC, judges which candidates to support based on recommendations. TRALAPAC is bipartisan and determines which candidate to support based solely on industry factors.

TRALAPAC — Important Operating Points

- TRALA, through its members and its general fund, pays for TRALAPAC's operating, administration and solicitation costs. This allows all TRALAPAC contributions to go directly to candidate's campaigns so that every individual dollar given has no overhead costs.
- TRALAPAC will not achieve "multicandidate" status until we receive PAC contributions from more than 50 contributors, it contributes to five or more federal candidates, and our registration with the FEC is in existence for longer than six months. The consequences of not being a multicandidate PAC is that TRALAPAC can now only contribute up to \$2,500 per election per candidate (it will increase to \$5,000 per election once we achieve multi-candidate status).
- TRALAPAC only solicits restricted class members— the key executives of TRALA member companies that directly participate with the association on a regular basis – and not the general employees of any company.

TRALAPAC — Rules

- The maximum an individual may contribute to TRALAPAC is \$5,000 per calendar year.
- TRALAPAC contributions are not tax deductible.
- Any contribution must be made with personal – not corporate – funds through a personal checking account. Federal law prohibits contributions made with a corporate check or credit card.
- Anyone can decide whether to contribute or not without worry of retribution. Your decision to contribute or not to contribute will have no bearing on your continued membership within TRALA.
- You must be a U.S. citizen or hold a valid green card to contribute to TRALAPAC.
